From 7 November 2015, such products shall only be manufactured or imported in accordance with the revised requirements.

10、Ecuador – Proposed The Ministry of Industry and Productivity of Ecuador (MIPRO) has proposed the Ecuadorian draft Technical Regulation PRTE INEN 259 "Childcare articles. Baby walkers".

If approved as proposed, it shall enter into force after 180 calendar days from its publication in the Official Gazette. Here are highlights of the proposed regulation:

13 India - Draft Rules on Prohibition of PET or Plastic **Containers for Liquid Oral** Drugs (Oct.30) 印度-口服药用PET或塑料容 器条例草案

Content: The Department of Health and Family Welfare of India has proposed draft rules in the Gazette of India, under Notification No. G.S.R. 701(E), in order to ban the use of Polyethylene Terephthalate (PET) or Plastic containers by manufacturers in liquid oral formulations for primary packaging of drug formulations for paediatric use, geriatric use and for use in case of pregnant women and women of reproductive age group. If approved as proposed, these rules shall come into force after 180 days from its final publication in the Official Gazette.

14、Honolulu/Hawaii/USA Approved Amendment to the Ban on Plastic Checkout Bags and Non-Recyclable Paper Bags(Oct.30)

Content: In the City and County of Honolulu of Hawaii, Ordinance 14-29 Relating to the Use of Bags Provided to Customers has been approved to amend Sections 9-9.1 and 9-9.2 of the Revised Ordinances of Honolulu 1990, as amended. From 1 July 2015, the ban on plastic checkout bags and non-recyclable paper bags shall be changed to as below: Businesses shall not provide plastic checkout bags and non-recyclable paper bags to their customers at the point of sale for the purpose of transporting groceries or other merchandise. However, a business can make available to customers, with or without charge, at the point of sale:

- reusable bags, compostable plastic bags, or recyclable paper bags for the purpose of transporting groceries or other merchandise; or

15 City of Fort Collins/ Colorado/USA - Approved Regulations Regarding Disposable Bags(Oct.31)

In the City of Fort Collins of Colorado, Ordinance No. 099, 2014 has been approved to amend Chapter 12 of the Code of the City of Fort Collins to establish regulations regarding disposable bags. This Ordinance shall take effect on 1 April 2015.

Content: In the City of Fort Collins of Colorado, Ordinance No. 099, 2014 has been approved to amend Chapter 12 of the Code of the City of Fort Collins to establish regulations regarding disposable bags. This Ordinance shall take effect on 1 April 2015. Here are highlights of the

- 1. The retailer shall collect from the customer, and the customer shall pay, a disposable bag charge of no less than \$0.05 at the time of purchase for each disposable bag provided to a customer.
- 2. All retailers shall record the number of bags provided on the customer transaction receipt and the total amount collected for such charge.
- 3. All retailers shall not provide, and customer shall not receive, a disposable bag unless such customer has given consent to purchase such bag.
- 4. All retailers shall not provide a rebate or in any way reimburse a customer for any part of the charge.
- 5. All retailers shall not exempt any customer from any part of the charge for any reason except that the retailer participates in a federal or state food assistance program and the customer provides proof that he or she is a participant in a Food Assistance Program.
- 6. Retailers can provide incentives for the use of reusable bags through credits or rebates for customers who bring their own bags.
- 7. Customers shall be able to use bags of any type that the customers bring into a retail location or carry away purchased that are not placed in a bag.
- 8. The retailer may retain all monies collected for any charge.
- 9. Each retailer shall maintain accurate and complete records of the charges collected, the number of bags provided, and shall also maintain documentation necessary to verify the accuracy and completeness of such records. Each retailer shall keep and preserve all such documents and records for 3 years from the end of calendar year of such records.
- 10. frequested, each retailer shall make the foregoing records available for inspection and audit by the City during regular business hours.

The State of Michigan has 2 bills (SB 1027 & 1057) in the same title introduced to propose Proposed ban on personal the ban of manufacturing, selling or promoting personal care articles containing plastic

Content: According to the bill (SB 1027), beginning 1 January 2018, no person shall manufacture for sale a personal care product, except for an over-the-counter drug that contains plastic microbeads, Beginning 1 January 2019, no person shall

a) accept for sale a personal care product, except for an over-the-counter drug, that contains plastic microbeads

b) manufacture for sale an over-the-counter drug that contains plastic microbeads

Beginning 1 January 2020, no person shall accept for sale an over-the-counter drug that contains plastic microbeads, According to the bill (SB 1057), Beginning 1 January 2019, no person shall sell or offer for promotional purposes any personal care products containing plastic microbeads. However, this does not apply to products containing plastic microbeads in less than 1 part per million (ppm) by weight.

Plastic microbead" means any intentionally added non-biodegradable plastic particle less than 5 millimeters in each dimension and used to exfoliate or cleanse in a rinse-off

ISO Publishes Revised ISO 4210-14 Cycles — Safety requirements for bicycles 国际标准化组织发布新版本ISO 4210-14 自行车安全要求 ISO 4210-14 规定了完全组装或部分组装自行车的安全性能要求和测试方法。标准中将自行车分为:



The ISO 4210-14 specifies terms and definitions related to safety and performance requirements for the design, assembly, and testing of bicycles and sub-assemblies having saddle height as given in below table:



企业社会责任意识在欧美等多国都已得到社会各界的广泛认同,在中国也越来越受到企业的重视。它主要强调企业在创造利润、对股东承担法律责任的同时,还要承担对员工、消费者、社区和环境的责任,企业社会责任和持续发展相互补充如果企业没有履行自己的社会责任或没有得到来自社会的支持,其发展和壮大都会受到影响。由此,企业社会责任被视为一个新的技术性障碍,越来越多的工厂被买家要求接受审核以确保订单。

### CPI全球供应链安全验证认知培训:
