1、 Korea – The Designation of Safety and Labelling Requirements for certain Products (Sep.2,2015)

The Korean Ministry of Environment has published the Notice No. 2015-86 “Designation of Products of Concern over Risks and Safety and Labelling Standards” to specified certain products of concern over risks. This notice has already come into effect.

2、 India – Proposes Revisions of Toy Safety Standard Related to Mechanical and Physical Properties. (Sep.4, 2015)

The Bureau of Indian Standards (BIS) has proposed the Third Revision of IS 9873 (Part 1), Safety for toys – Part 1: Safety aspects related to mechanical and physical properties, for aligning the Indian Standard with ISO 8124-1:2014.

印度-提出了修订相关的机械物理性能的玩具安全标准。(2015.9.4)

印度标准局(BIS)提出了第三版IS 9873 (Part 1), 玩具安全 – Part 1: 机械物理性能的玩具安全要求的修订，意在与ISO 8124-1:2014相统一。

3、 United Arab Emirates -Control Scheme for Articles Intended to Come into Contact with Food. (Sep.10,2015)

United Arab Emirates (UAE) issued Decision of the Cabinet No.20 of 2015 on the control scheme for articles intended to come into contact with food. Suppliers shall follow this Decision by 25th Jan, 2016. (Not later than 180 days from 29th Jul, 2015) and products non-conforming with the requirements specified by this Decision will not be allowed to circulate within the country by 28th Jul, 2016.

阿拉伯联合酋长国（ UAE ）颁布了内阁2015年第20号决议-食品接触产品控制方案。供应商需要在2016年1月25前遵守该决议（ 2015年7月29日后180天 ）。在2016年7月28 前不符合该方案要求的产品将不得流通。

4、 USA – CPSC Withdraws Direct Final Rule for Determination Regarding Heavy Elements Limits for Unfinished and Untreated Wood in Toys (16 CFR 1251) (Sep.10, 2015)

The U.S. CPSC has withdrawn the direct final rule for determination regarding heavy elements limits for unfinished and untreated wood in toys (16 CFR 1251) due to significant adverse comments. The withdrawal is effective immediately.

5、 Korea - Symbol for Food Contact Article (Sep.10, 2015)

The Korean Ministry of Food and Drug Safety has published the Notice No. 2015-20 “Labelling Standard of Food” to specified symbol for food contact article. The food contact article or its packaging shall carry the symbol with either one of the following designs. This notice has already come into effect.

6、 California/USA - Approved amendment of labelling of “Made in U.S.A.”(Chapter 238) (Sep.11, 2015)

美国加利福尼亚州-核准了关于标签“Made in U.S.A.”的修正案(238章)。(2015年9月11日)

The governor of California signed the Bill No. 633 under chapter 238 relating to “Made in U.S.A” label. As California is the only state in the country that establishes a 100 percent domestic made requirement compared with all 49 other states and the federal government, this bill amended the existing law to use more flexible standard for determining when a product is eligible to be labeled as “Made in U.S.A.,” “Made in America,” “U.S.A.,” or similar

加利福尼亚州州长签署了第633号法案，相关于第238章“Made in U.S.A”标签。加利福尼亚州是美国唯一一个有别于其它49州及联邦政府的州，该州提出了一个100%国内制造的要求，这个法案修正了现行法规使之更加灵活的判定什么时候产品是符合条件来贴“Made in U.S.A.,” “Made in America,” “U.S.A.,”或者类似的标签。

This bill will go into effect on the first day of January 2016. Products fulfilled the following sections can be labelled as “Made in U.S.A.,” “Made in America,” “U.S.A.,” or similar words if:

1. the merchandise has one or more articles, units, or parts made from outside the United States if they do not constitute more than 5% of the final wholesale value of it.

2. the manufacturer shows that it can neither produce the article, unit, or part within the United States nor obtain the article, unit, or part of the merchandise from a domestic source (cannot base on the cost) and they do not constitute more than 10% of the final wholesale value of it.

The requirements shall not apply to the following situations:

I. merchandise sold for resale to consumers outside of California

II. merchandise sold or offered for sale outside of California shall not be deemed mislabeled if the label conforms to the law of the forum state or country within which they are sold or offered for sale.

1. 商品有一个或多个部件、单元或零件是在美国以外的地方制造，但是这些部分占商品最终的批发价值不超过5%

2. 制造商表示既不是在美国本土生产也不是从国内的来源获得的商品的部件、单元及零件（不是基于成本）占商品最终的批发价值不超过10%。

这些要求不适用于以下情况：

在加利福尼亚州范围以外售卖给消费者的商品

在加利福尼亚州以外售卖或者标价出售的商品，如果标签符合商品售卖所在国或者州的法律不被认为是贴错标签。

7、 Brazil - Proposed Revised Conformity Assessment Procedures for Toys. (Sep.16,2015)

The National Institute of Metrology, Standardization and Industrial Quality (INMETRO) of Brazil has proposed revised mandatory Conformity Assessment Procedures for Toys for public consultation under Portaria No.428/2015.

The French Constitutional Court has published the Decision No. 2015-480 QPC to lift the ban on manufacturing and exporting food contact packaging, containers and utensils containing bisphenol A (BPA). The decision is effective immediately. However, the suspension of importing and placing on the market shall stay valid.
